## 7 New Business

7.1 Brian Shuck/Jeff Wilson - Fall City Business District LOSS Project presentation.

#### Alternative 1 overview

- combined space using smaller use of the park and Valley Christian.
- Pre-treatment and aerobic treatment units/natural treatment component using trees planted using an ecolotree system
- Subsurface irrigation can provide irrigation for plants/parcel has been disturbed in past from soil testing 4-18 inches of disturbance grading – sub surface needs to be installed nonnative – deeper they go less able to establish grass.

#### **Alternative 2 overview**

- Liquid only pressure system.
- New septic tanks to businesses and pump to Bernard Park
- No trees clarifying tank residual stuff is settled before pumped to treatment could still add the tree system if budget would allow
- All the flow goes to the park
- Required to be 100 feet away from highwater mark of the river, this is a Washington State rule
- subsurface drip zones

#### **Alternative 3 overview**

Combination of the two above

# **Shared a rendering of Bernard Park**

- Uses as much of the space for LOSS
- Add bathroom, park entrance 340<sup>th</sup>, park exit 341<sup>st</sup>, playground, volleyball, open space/plants, picnic area.
- These items can be included in renderings, but fiscal, design and construction responsibilities are of the Park District.

## **HOA**

- The county will design and construction, then hand over management to an HOA developed with the business owners - after 10 years it could transfer to sewer district
- Bernard Park (Fall City Park District) would want to enter into agreement to HOA regarding easements and accommodations
