- 5.3 Trail Connections/West Side Trail (Harris)
 - Commissioners Harris and Watts met with the trail design consultant, OTAK, to review and discuss a new set off design and documentation requirements from WSDOT. Items include stormwater runoff issue which involves soil infiltration testing and establishment of monitoring wells, a tree removal mitigation plan, a public art plan, and a visual impact assessment memorandum. Another added work effort is to develop separate project bid documents for each construction phase, which correlates with the \$500,000 grant received in 2023 from King County Parks to construct Phase 1 in 2024. The costs for the added work have been identified by OTAK in a proposal submitted to the District. Commissioner Harris is requesting the Board's authorization to execute the supplemental agreement for \$94,189 to cover the additional costs.

Commissioner Watts moved to approve \$94,189 for these added requirements, Commissioner Holbink seconded the motion; motion was approved unanimously.
